## 2026 Annual All- Club Fundraiser Car Raffle – Official Terms & Conditions

### Sponsor:

### 1. Eligibility

- Participants must be **18 years of age or older** at the time of ticket purchase.
  - Raffle is void where prohibited by law.
  - Employees, board members, and officers of Boise Timbers Thorns Soccer Club and Peterson Toyota, and their immediate family members, may purchase tickets unless otherwise restricted by law.

### 2. Ticket Information

- **Cost per ticket:** \$20 (USD)
  - Tickets are non-refundable and non-transferable.
  - No limit on the number of tickets an individual may purchase.
  - Odds of winning depend on the total number of tickets sold.

#### 4. Prizes

#### 5. Vehicle Prize Conditions

- The Grand Prize winner will be contacted within **24 hours** of the drawing using the information provided at the time of ticket purchase.
  - **Vehicle delivery must be completed by May 26, 2026, or within a reasonable extension approved by the Sponsor due to availability or administrative delays.**
  - If the Grand Prize winner fails to complete delivery and payment of required taxes and fees by this deadline, the prize will be forfeited.

- If the Grand Prize is forfeited, the **Second Place winner** will be notified and will have **14 days** from the date of notification to take delivery of the vehicle and pay all required taxes and fees.
